

Something to think about... I would like to address something we often forget about and that is the need to accommodate snowmobilers with special needs so they too can enjoy the snowmobiling experience equally as everyone else does. We are often reminded we need to treat everyone fairly by accommodating ADA (Americans with Disabilities Act) access to restroom facilities, parking spots, elevators, ramps, etc, etc, etc in our everyday lives, and it is required we provide ADA access to all of our state

grooming meetings. Therefore, I think we should equally make sure we provide ADA parking, restroom access and adequate trail grooming to all state-funded groomed trails and sno-parks to allow everyone adequate access to enjoy snowmobiling. We often forget we have snowmobilers who have suffered accidents, whether it is a veteran fighting for our country and our freedom, others who have been born with special needs, or those who have faced trauma in their life that has left them as an amputee or with other special needs. Contrary to popular belief that only fully able-bodied persons can own and operate a snowmobile, there are many who have special needs and have spent thousands of dollars for a new snowmobile to enjoy snowmobiling as much as everyone else. They pay the same license fees and deserve to have trail grooming on all mapped groomed trails, along with cleared sno-park parking and unobstructed bathroom access in the sno-parks. There was a popular sno-park this season that the bathroom was fully obstructed and encapsulated in an eight-foot wall of snow by way of snow removal equipment that left it impossible for someone with special needs to access. It was the great efforts of the local snowmobile club who cleared the wall of snow to allow everyone to have access to the bathrooms. Let's all be mindful of everyone's needs so we all can have a great time snowmobiling in Washington State. Off-season preparations for your sleds and trailers; it's getting that time of year when some begin to put their snowmobilers and trailers away for the spring and summer. Please remember to take those preventative measures to ensure your sleds and trailers perform well at the beginning of next season. Grease those fittings on your suspension to keep the moisture out. Grease those bearing buddies on your trailer wheels to prevent corrosion and moisture. Top off your sled with non-ethanol fuel and add fuel stabilizer. Fog your engines to prevent rust and corrosion. Empty your cookers of all food to keep rodents from having a summer time buffet under your hood. Wax your sled to keep the finish protected, and elevate your sled off its suspension or at least off your track.

It's not too late... I encourage you to register your sleds if you have not done so this season. Though you might feel it's not necessary at this point, it is necessary in order to keep our trails groomed and snow removed from the parking lots next year. We are down snowmobile registrations for this

year, which equates to less grooming next year. So please take the time and register your sleds!

Stay safe out there and I hope to see you on the trail somewhere soon.

State Parks appoints new agency director

Nationwide recruitment efforts lead to internal talent

The Washington State Parks and Recreation Commission recently announced the appointment of Diana Dupuis as the agency's new director. Dupuis will be the first female director since the agency was established more than 100 years ago.

"Diana is a strategic leader with extensive experience in parks. She has dedicated more than 14 years to our agency," said Parks Commission chairman, Mark O. Brown. "I am pleased to welcome Diana as the new director. She has a deep understanding of our agency, and I am confident that her expertise will help us achieve our goals."

As director, Dupuis will serve as the leader for one of the country's most beautiful and diverse park systems that includes more than 120,000 acres, 124 developed parks, numerous properties and heritage sites and a team of nearly 1,000 dedicated staff.

Dupuis' first day as director will be April 1st.

Dupuis is currently the region manager in Spokane. Previously, she served as a park ranger, LEAN practitioner, area manager and operations manager. Prior to joining Parks, Dupuis worked as an adjunct faculty member at Green River Community College in the Department of Anthropology and the Department of Criminal Justice. Dupuis also served on the special operations response team with the Los Angeles County Medical Examiner-Coroner office.

"I am honored to serve as the next director for the Washington State Parks and Recreation Commission and am grateful for the confidence the Commission has placed in me," said Dupuis. "I'm excited to work with the Commission, staff, partners, elected officials and members of the public to continue growing our agency and creating welcoming recreational opportunities for all visitors."

Dupuis holds a master's degree in Anthropology from California State University, Los Angeles and a bachelor's degree from Indiana University. She grew up in Indiana and Michigan and spent her childhood immersed in the outdoors year-round. Dupuis enjoys snowshoeing, hiking, running, bird watching and camping with her wife, daughter and stepson.

Membership Matters

As we approach the end of the 2021-22 snowmobile season it's a good time to recap our membership for the past year. Our membership year runs from September 1st through August 31st; however, our fiscal or budget year runs from March 1st through the end of February. It has been a longstanding practice that anyone joining after March 1st gets the remainder of the current year as well as the following full year of membership for \$25. If you've been thinking about joining, this is a good time to go ahead and do it. Overall, there was a 3.5% increase in membership this past year. Our current membership, as of March 1st, was 946 primary members (Family/Individual, Clubs, and Associate members) as compared with 913 last year. The good news is there were 119 new Family/Individual memberships. When you consider there are over 24,000 snowmobiles registered in Washington, which probably represents 10,000 to 11,000 households, it's pretty easy to see we have a lot of room to grow as our paid membership only represents about 8 to 9% of the snowmobilers in Washington. To be effective in representing the interests of snowmobilers we need more members. With maintaining access to riding areas being our most important priority, we need snowmobilers to get involved with WSSA and to represent snowmobilers' interests on a wide variety of committees, councils, boards, and clubs. Various agencies, land managers, and legislators are making decisions that will impact whether or not we will have riding areas in the future. As snowmobilers, we need to be involved in those decisions. No one will do this for us.

A big 'thank you' to all our members, from those who joined this year to those who joined in 1972. Remember, this is our 50th year!







Coming up we have another joint gathering with the Boondockers; an 'End of the Season Barbecue' on April 30th to gather


and thank the groomer guys!

Join us at Round Table Pizza at 6pm if you'd like to check us out.





American Council of Snowmobile Associations Mountain Riding Area Committee Winter Summit Meeting Minutes

West Yellowstone, Montana, February 25th, 2022

This ACSA (American Council of Snowmobile Associations) Mountain Riding Area Committee meeting was called to order at 8:00 AM by Facilitator Bert Miller.

Roll Call: Facilitator Bert Miller, Co-Facilitator Dennis Jordan (OR), ACSA Executive Director Christine Jourdain, Scott Chapman (ID), Fred Bailey (MT), Daryl Holmberg (NE), Duane Duerr (SD), Cal Taylor (UT), Dean Meakin (WA), Brenda Miller (WY), Lisa Mahoney – Recorder.

Also present; Jason Howell, Kevin Bazar, Dennis Troy, Andrea Willey, Chris Willey, Jack Welch, Greg Hiles, Diane Hiles, Brian Erickson, Tracey Erickson, Taylor Jones, TJ Reilly, Connie Walter, and Forrest Kamminga, Brett Slaughter (aide to Senator Steve Daines - MT), Cliff Walter, Seth MacArthur, and Mason Long.

Opening remarks: Bert Miller visited about the direction of the Riding Areas Committees. We hope to have our Riding Summits meet in Washington D.C. and then a Riding Areas full group meeting at the International Snowmobile Congress (ISC). Our meetings are open forum concept; please raise your hand and you will be recognized. The Riding Area Committees report to the ACSA board; we are your voice.

Christine Jourdain talked about the D.C. Fly-In. We are not going to the Fly-In. In order to attend, a vaccination status survey must be filled out before you can get an appointment for some legislators. Christine recommended we continue to work within our Districts in the meantime.

Jason Howell asked about the RTP (Recreational Trails Program). Christine explained some legislators are recommending changes to the RTP. She is concerned about the introduction of electric vehicles and how that affects the gas tax/RTP.

Calendar sales are up. The No Trespassing campaign has been fun and educational. We are still looking for a 2024 host for ISC. Christine talked about 30 X 30 legislation; thirty percent of land and waters restricted by 2030. No changes in legislation.

Brett Slaughter, aide to Senator Daines, talked about what is going on with 30 X 30. Christine said that a big issue is constant rotation of people in the Forest Service and Washington.

BLM (Bureau of Land Management) is back in D.C. It should be in the West where the land is. We need to be vigilant in watching bills that get introduced.

Bert stressed the importance of every state snowmobile representative to stay current with legislators and Forest Service Rangers. Christine warned about major changes, omnibus bills, and midnight sessions after elections.

ISC 2022 is in 102 days. Chris Willey (IA) talked about all of the exciting things happening at ISC 2022. Hotel is at half capacity. CALL, don't go online, for reservations.

Christine stated all topics talked about so far affect all snowmobilers. The Mountain Riding and Trail Riding groups need to converge. Bert talked about how successful this meeting has been. This is an open forum, so ideas are talked about freely. He also talked about how much alike both riding groups are.

Brian Erickson talked about the ACSA Survey. He talked about the UTV/ATV aspect. We got positive results from the survey. ACSA is not a recognizable brand. ACSA was given a 4.2 approval rating out of 5 score. Every state should be sharing the ACSA Enews. There was a recommendation to share Facebook posts for ACSA's Enews in Instagram. Dean Meakin recommended sending out surveys more often. A big thank you to Len Nesler for putting together the survey with Survey Monkey.

Chris Willey, ACSA Delegate at Large, talked about the ACSA 'No Trespassing' and 'Who Is ACSA' videos. He asked for 15-30 second video clips of what ACSA means to you or what ACSA does for you. These videos will be shared with Facebook, TikTok, and Instagram for marketing of ACSA. It is important to know where you are when riding. Send the videos to Chris Willey at kioti79@gmail.com.

We don't have a TikTok account, but Chris will look into it. We need to harness social media. Jason Howell recommended a state level TikTok Challenge or a blooper videos. We need to put a face to ACSA. He recommended sharing organization information through e-mail from President instead of treasurer/secretary. Also need to drive home the need for club presidents/ secretaries/treasurers to share with their clubs. Many times information stops at the

club rep level. Cal Taylor recommended having club members sign up for e-mails directly from ACSA to avoid the lag in information or dead end on club rep level. Christine recommended QR codes. Chris Wiley recommended coming up with a hashtag for ACSA.

Bert discussed Yellowstone Park follow-up. He talked about getting an increase in snow-mobile traffic in the Park. Jack Welch talked about stats for the Park. We are working to get more non-guided snowmobile rides through the Park.

State Reports:

- Idaho Scott Chapman, Vice President Donated \$5k to Sierra Snow mobile Foundation. Snowmobile trails are an issue. Tracked vehicles on snowmobile trails may go away. Gained land in lawsuit on Forest Service land. Wolves are a problem for caribou population. Climate change has contributed to it. The riding area is closed until the population comes back. March 12th is a disabled veteran ride in McCall.
- Montana Fred Bailey, President -It's been a good year for snow. Jason Howell and Connie are staying on to help with a smooth transition. They have a new website. They can mass mail, print reports, and newsletter with new website. MSA (Montana Snowmobile Association) convention had 47 riders and the snow was great at Lolo. The banquet was in Hamilton. Handed out five MSA awards. Highlight was the Governor attended the dedication of a brand-new groomer. He came in by helicopter. He is supportive of motorized access. Two potential lawsuits coming up. Clearwater - Senator Tester to grab land. MSA filing lawsuit against the Forest Service Travel Plan to close trails.
- Nebraska Daryl Holmberg Not much going on in NE. It has affected enthusiasm for snowmobiling. ISC in Nebraska has helped. Thank you for everyone that attended. State ride going on next week in the Big Horns. New person running for Senate. Not sure if he is familiar with snowmobiling.
- Oregon Dennis Jordan, President This year is our 50th year anniver-sary. Dennis talked about how OSSA was started. TJ Reilly is new Vice President. Lisa Burt is new Assistant Executive Director. (Continued on page 24)

New avalanche safety coordinator Chuck Ehlert. He is working with the state avalanche forecasting. Brand new website which is hosted by GrowthZone. RTP grant for 'Are You Beeping?' boards for 24 locations around the state. RTP grant for new Tucker Sno-Cat. Over 42k miles groomed in 2020-2021 by our volunteer groomers. Membership is up 20% to just over 1,300 family memberships.

- South Dakota Duane Duerr, President - New Sno-Plainsman went to magazine style from newspaper style. Working on a phone app to pull up trail maps and other state snowmobile information. Membership is good. UTVs and ATVs are being left alone. No snow has been a challenge. Early membership has helped with membership. Looking forward to next year to make up membership. Governor's Ride has been cancelled. Mission statement listed on a sheet. Legislators like coffee mugs engraved with their name and our logo and snowmobile info. Hand-delivered preferred. Using it as a tool to build relationships with legislators. Clubs are still active. New online safety course. South Dakota Convention in Aberdeen, SD, next year. Introduced trail cams to look at snow conditions.
- Utah Cal Taylor, President Michael Davis, Public Lands Director, doing a fantastic job. Low snow has hindered many activities. Poker Ride coming up March 5th. Kids Day is March 19th. This is the last year for Cal. Chris Howler took an early retirement. No replacement for his position
- Washington Dean Meakin, President - 50th Anniversary for WSSA. Washington still on lockdown. Mandatory vax cards have really put a stop to many activities for the organization. March 12th meeting is coming up. Hopefully it will be face-to-face instead of Zoom. Lawsuit threatened in Okanogan NF regarding outfitters: permit for installation of alpine huts in highly used snowmobile area (Van Epps Pass). Cost (legal fees) to WSSA was \$30k. WSSA dropped going forward with lawsuit as the remedy they were seeking was provided, for now... Hoping for spring snow.

Nothing legislative. Snow show expo at 50% last fall. Conflict with the Utah show. Their venue got pushed back. Next year WA show is October 14th and 15th. Membership up 3%. Snowmobile registrations up 2.3%. Winter Rendezvous cancelled. WSSA Board elections are March 12th. Snowmobile Program Manager, Pamela McConkey, is retiring. She will be missed. Kay Lloyd, first ACSA President, passed away January 19th, 2022. A memorial service will be held in Cle Elum, WA. Contributions to be made to ISHOF (International Snow mobile Hall of Fame).

• Wyoming – Brenda Miller, President - State convention in Rock Springs next weekend. No snow so there will be rides on sand dunes. Jackson Hill Climb will be back to normal capacity. Keeping an eye on 30 X 30. Great working relationship with District Ranger. Selling Wyoming raffle tickets. Proceeds go to the scholarship and ACSA. ACSA calendars for sale. Forrest talked about the state of Wyoming partnering with WSA to carry BCA radios for SAR campaign. 'Be 307 aware'.

Sierra Snowmobile Foundation – Dennis Troy and Kevin Bazar - Dennis Troy talked about the Foundation which is based out of Reno, NV. Organized for California/Nevada snowmobilers. Mission is to keep land open for snowmobiling.

Kevin Bazar is land-use advocacy guru for the organization. He gave a PowerPoint Presentation on how the Travel Management Rule for over-snow vehicles got its start. The over-the-snow plan being introduced is calling for a 12" minimum to groom. Lawsuits cited:

- Case No. 1:11-CV-586-REB
- Case No: 2:11-CV-02921-MCE-DAD

Kevin stated Winter Wildlands uses anything to limit or eliminate snowmobiling.

Case No: 2:21-cv-01913 was filed on October 13, 2021, by Sierra Snowmobile Foundation, Jeff Wittman, ACSA, John Watts, Mary Krupka, and BlueRibbon Coalition against the U.S. Forest Service, Jason Kulken, and the USDA (U.S. Department of Agriculture).

Skidoo gave a grant to help with the lawsuit. Sierra Snowmobile Foundation, et al., v. United States Forest Service, et al., (2:21cv-01913), California Eastern District Court (pacermonitor.com) Facilitator Bert Miller asked Past President Greg Hiles for his closing thoughts. Greg closed the meeting with his thoughts of the value that ACSA has to all of us. The ACSA organization serves all snowmobilers alike by bringing us together. Without ACSA we would lose our public lands to snowmobile on, thank you all.

Meeting adjourned at 12:00 PM.

WSSA Grant Program

The WSSA Trail/Trail Head Grant Program is a quick and easy way for a club to receive help with small projects. Grants are limited to \$1,000 per club, but clubs can team together on one project, increasing the total funding. (Each club must submit a separate application.)

The grant process is simple. The clubs applying for a grant must have current membership in WSSA. The deadline to apply is April 15th. The grants will be awarded by June 15th. This will allow the clubs to perform the work in the prime summer and fall months. (Projects must be completed by December 31st, upon which time photos and an article on the project are to go to the Snoflyer for publication. If this trail grant is being used for matching an NRTP grant, please state that and the grant will have the same completion date as the NRTP grant.)

Please be sure to read the grant application carefully as there are two items that must be attached to it--a map of the project site, and landowner permission. Grant applications without these two items will not be considered for funds.



At least 30 state House Speakers, Senate Presidents and majority leaders have either resigned or said they will retire at the end of their current terms, according to a tracker maintained by the National Conference of

It's a great time to get to know the candidates that may be Friends of Snowmobiling!

Congressional negotiators reached a bipartisan \$1.5 Trillion deal to fund the government as pressure mounted to wrap up spending talks amid the ongoing crisis in Ukraine.

In addition to a \$42 Billion increase for nondefense discretionary spending in four years and a \$42 Billion increase for defense spending in the package, the bill also includes \$14 Billion in emergency funding to boost humanitarian, security and economic assistance for Ukraine and central European allies. Interesting that the proposed \$15 Billion in COVID supplemental funding offset by an earlier rescission of funds was removed.

The U.S. Senate voted 79-19 to provide the Postal Service (USPS) with about \$50 billion in financial relief over a decade and requiring future retirees to enroll in a government health insurance plan.

The action, after the U.S. House of Representatives overwhelmingly approved the measure in early February, sent the bill to the President for his signature. USPS has reported net losses of more than \$90 billion since 2007, and recently reported a net loss of \$1.5 billion for the quarter ending Dec. 31th.

Russia is a commodities giant. In addition to being a major oil, natural gas and potash producer, it is also a major exporter of logs, lumber, pulp and pellets.

Yellowstone National Park captured 37 bison that were migrating outside the park as officials began an annual program to cull the animals to prevent them from spreading disease to cattle in neighboring Montana, a park official recently stated. Twenty-seven of the bison captured were sent to the Confederated Salish and Kootenai Tribes for slaughter and will provide food for tribal members.

Officials are aiming to remove up to 900 of Yellowstone's 5,000 bison this winter through slaughter, relocations and hunting. The goal is to keep the park's herds from growing and prevent the spread of the disease brucello-

sis, under an agreement between state, federal and tribal officials.

In Case You Missed This...

No '30 by 30' in Montana: Governor Greg Gianforte announced the state of Montana declines to participate in the U.S. Department of the Interior's (DOI) efforts to advance President Biden's '30 by 30' initiative, calling it "long on philosophy and short on detail."

President Biden's '30 by 30' initiative aims to conserve 30% of America's lands and waters by 2030. The U.S. Geological Survey indicates 12% of U.S. land is in conservation status. To achieve 30% by 2030, another 440 million acres would need to be put into conservation, an (Continued on page 28)



WildEarth Guardians and the California Wilderness Coalition have intervened in a lawsuit brought by snowmobiling interests against the Forest Service for decisions made in their over-snow-vehicle (OSV) trails and areas plan on the Stanislaus National Forest in California's Sierra Nevada.

They "intervened in the lawsuit because the Forest Service hasn't properly considered the impacts snowmobiling will have on an isolated remnant population of 18 to 39 Sierra Nevada red fox, which live within the Stanislaus National Forest in the vicinity of Sonora Pass (elevation 9628')".

You may recall the Sierra Snowmobile Foundation, along with the American Council of Snowmobile Associations and other parties, filed suit against the Forest Service in October because of the restrictions in the over-snow-vehicle designations in the Forest Plan. Among the restrictions are a 12-inch snow depth minimum for snowmobile grooming as well as many land closures.

The Sierra Snowmobile Foundation has a fundraiser for their legal fund with all proceeds going directly to the Sierra Snowmobile Foundations legal fund. Tickets for the 2022 Ski-Doo Summit SP 154 E-TEC start at \$25 for 10 tickets. The drawing will be May 1st. The Wolverine and the Endangered Species Act

Environmentalists and the Fish and Wildlife Service (FWS) are at odds over whether a Trump Administration rule should remain in place while the federal agency reconsiders protections for the wolverine.

Pressed by litigation, the FWS has already relented on one front and agreed to take another look at the prior administration's decision not to list the wolverine under the Endangered Species Act.

But in the meantime, the FWS insists the Trump Administration rule concerning the wolverine should remain, technically at least, on the books.

"Many other courts have recognized that even 'a flawed rule need not be vacated' and when equity demands, the regulation can be left in place while the agency follows the necessary procedures to correct its action," the Justice Department stated in a recent court filling.

FWS has committed to completing a new assessment within 18 months of the court's ruling on this motion.

Did You Know?

Hardwood plywood is used in many U.S. finished goods including kitchen cabinets, recreational vehicles, mobile homes, flooring, and furniture, and a source of that plywood might be cut off due to the Russian invasion of Ukraine.

TimberCheck, a website covering the timber industry, estimates that 10% of its hardwood plywood in the U.S. originates directly from Russia. In addition to sanctions by the European Union (EU) banning lumber from Russia and Belarus, other groups are asking the U.S. and other countries to ban lumber imports. In the Ukraine, more than 120 environmental rights groups have called for a ban on Russian and Belarussian timber in response to Vladimir Putin's invasion of Ukraine.

Russia recently sought to retaliate against Western sanctions imposed over its invasion of Ukraine by banning exports of certain goods and agricultural commodities. The list of products includes forestry products and equipment, as well as telecom, medical, auto, agricultural, electric and tech equipment, according to Reuters. Containers and railway cars also made the list. These products will be banned until the end of 2022.

Nearly a third of the top leaders in the nation's 99 state legislative chambers will quit their posts this year, signaling a wave of turnover that will hand power to a new generation.

(Continued from page 27) area nearly five times the size of Montana.

Surging diesel prices... Diesel prices in recent days passed \$5 a gallon nationally, and there are some areas that are even higher. That's a big increase from the \$3.08 national average a year ago according to AAA.

While the talk of diesel prices is directed at the farming community, it will also impact the snowmobile community with the increased cost of grooming.

In a job posting that's gone viral, the Fish and Wildlife Service invited applicants to coordinate grizzly bear conflict management in Montana, Idaho, Wyoming and Washington state.

On the one hand, the pay is good, with the salary as high as \$103,176 a year. On the other hand, adult male grizzly bears average upward of 600 pounds and can sprint up to 35 mph.

"He/she may need to carry a firearm for personal protection from wild-life," FWS cautioned potential applicants in the job posting.

It is estimated there are fewer than 2,000 grizzlies found in the Northern Rocky Mountains, mostly around Yellowstone and Glacier.

The conflict manager job includes working with states, tribes and others in making bear relocation and removal decisions and coordinating trapping efforts, monitoring and what the agency calls 'conflict prevention'.

EPA Truck Emissions

At a recent White House ceremony, EPA Administrator Michael Regan hailed a planned tightening of heavy-duty truck emission standards as a step toward slashing smog-forming pollution on the road and ushering in even cleaner alternatives.

Immediately, there were calls to either proceed more cautiously or act more aggressively.

'EPA's New Trucks Rule Fails to Deliver' was the title of an Earthjustice news release urging the agency to push the trucking industry toward electric rigs.

"For the sake of our lungs, our health and our climate, the future of trucking in this country has got to be zero emissions," said Paul Cort, director of the group's 'Right to Zero' campaign.

But at the Diesel Technology Forum, a trade group whose members include engine manufacturers, Executive Director Allen Schaeffer suggested moving too quickly on the electrification front could lead truckers to hold on to older, higher-polluting vehicles longer.

Under the newly issued proposal, EPA is floating two options to cut heavy-duty trucks' releases of smog-forming nitrogen oxides (NOx). The first would take a two-stage approach by successively tightening standards for model year 2027 vehicles and again for the 2031 models. The second would make a one-time tightening only, starting in model year 2027.

Science Says Thinned Forests = Healthy Forests

Forest Service science shows thinning and fuels treatments work. Historically, many Western forests were far less dense and extremely vari-

able. Trees often grew in clusters of two to 20, interspersed with several small gaps.

A Research Ecologist, Eric Knapp, studies the ecology of forests in relation to disturbance, particularly fire. As part of this research, he evaluated the results of forest management alternatives designed to reverse some of these changes, including mechanical thinning and prescribed fire.

Waters of the U.S.

Senator Lisa Murkowski (R-AK) hosted EPA's top water official last week for a conversation about the fate of 'waters of the U.S.', or WOTUS.

Murkowski has joined other Senate republicans in calling on the EPA to halt its rulemaking until the Supreme Court weighs in on a precedent-setting case involving the reach of the Clean Water Act.

The senator and her republican colleagues in a February 3rd letter warned the EPA and the Army Corps that it would be "irresponsible ... to proceed down a regulatory path that could be invalidated or significantly altered as early as this summer."

The senators expressed concern with the EPA's proposed rule, calling it a "land grab".

"The proposed rule seeks to federalize waters in a land grab that arguably surpasses its 2015 predecessor, improperly encompassing water features traditionally within the sole purview of states, while reverting from the comparative straightforward application of the 2020 Navigable Waters Protection Rule ... and interjecting new uncertainties for nearly every private sector stakeholder," they wrote.

The EPA and the Army Corps are setting up 10 regional roundtables to gather input; dates/location to be announced. There will be two meetings in the Southwest, Southeast, and West, three meetings in the Midwest and one in the Northeast.

Clean Snowmobile Challenge

The SAE (Society of Automotive Engineers) Clean Snowmobile Challenge was back to being a face to face event this year, after cutting the 2020 CSC short and holding a virtual event last year.

Polaris isn't going to be left behind in the electric vehicle market. Polaris has already unveiled its next-gen electric UTV and shown prototypes for ATVs and snowmobiles too. They are working through a partnership with Zero Motorcycles, a company specializing in electric cycles. Polaris' new Ranger XP electric UTV is going to be the

most powerful machine on the market with deliveries starting this year. Polaris hasn't fully committed to building a produc-

tion electric snowmobile, but they are testing them. There goal seems to be bringing to market vehicles that 'improves the customer experience'. If Taiga machines prove to be a success, it appears Polaris will be positioned to bring something to market fairly quickly.

It's here!... Over-Snow-Vehicle
Travel Planning. WSSA has been warning snowmobilers for several years this was coming and it has finally hit in Washington

State. Right now it is just a minor incursion as the rule-making process has started in the Panhandle National Forest which just brushes the northeast corner of the state. The plan is called the 'Kaniksu Over-Snow-Vehicle Travel Plan'. Two things are very im-



portant though. First, all of these new oversnow plans will set precedent. If something is included we don't like in one, it will likely appear in an upcoming Washington plan. And second, even though it barely applies to Washington, it does apply to Washington, meaning we need to have standing in the planning process in case legal remedies are sought in the future. A couple of items of concern with this plan include caribou habit, where snowmobilers have been banned from in the past and an area where the caribou no longer exist (as they were relocated to British Columbia), and now wolverine habitat. Regardless of validity, you can count on the extreme environmental groups using anything they can to limit or eliminate snowmobile use from this area. WSSA is engaged on this Panhandle plan and we ask you to participate in the rule-making process by submitting comments when the time comes. It is reported the Forest Service will be seeking public feedback on a draft proposal this year. In partnership with Lyme Great Lakes Timberlands, the Michigan Department of Natural Resources (DNR) purchased 103 miles of snowmobile trail easements for \$1.8 million with funds from the DNR's 'permanent snowmobile easement fund'. It was noted by Bill O'Brion, general manager of Lyme Great Lakes Timberlands, "Trail networks are integral to the economy of the Upper Peninsula and enjoy year-round use." The staff and the board of BRC also sought to create a logo that reflected the strength of the organization and members would proudly represent on their vehicles and wear with confidence. After evaluating more than 140 proposed logos presented by dozens of professional designers, the BlueRibbon Shield was chosen as a strong, simple, and easily recognizable symbol to represent BRC in their ongoing role as guardians of our right to recreate.

Look for this logo on BRC's social media channels, website, and in their current campaigns, which include 'Defend Your Ground' and 'Fight for Every Inch'. With the current National administration's goal of '30 by 30', protecting 30% of U.S. Lands from the public by 2030, the fight for our right to public lands has never been more volatile and BRC's cause never clearer and more necessary than right now.
